

**SlimGuard Gutter Protection  
20 YEAR LIMITED WARRANTY**

Subject to the terms, exclusions and other limitations of this Limited Warranty set forth herein, Industrial Converting, Inc. hereby warrants, exclusively to the original registered homeowner/building owner of the structure on which the SlimGuard Total Gutter Protection (hereinafter called SlimGuard) product is originally installed, that its SlimGuard product is free from defects in material and workmanship when it was shipped from the factory. SlimGuard, when properly installed for normal use, and with minimal regular maintenance, is designed to keep the interior of the gutters free-flowing for a period of 20 years from date of installation.


For a period of 20 years from date of installation, should material or workmanship defects present when the SlimGuard product was shipped from the factory result in a failure to keep gutters free flowing due to the interior of the gutters becoming clogged despite regular maintenance by the homeowner/building owner, Industrial Converting, Inc. will replace the defective SlimGuard product as set forth below.

For this Limited Warranty to apply, all of the following conditions must be met:

- SlimGuard must be purchased directly from Industrial Converting, Inc., or from an authorized re-seller of SlimGuard;
- All gutters must be thoroughly cleaned and all connected downspouts and any connected underground drains must be clear and free of debris and/or obstructions prior to installation of SlimGuard;
- SlimGuard must be installed according to SlimGuard's installation provisions and instructions;
- The original homeowner/building owner of the structure on which the SlimGuard is originally installed must register by completing and signing the Limited Warranty Registration Form below and returning it to Industrial Converting, Inc. within 30 days following the installation of SlimGuard;
- Gutters on which the SlimGuard is installed must be properly sloped and in compliance with all applicable state and local building codes.
- Because conditions vary on every SlimGuard application, the original registered homeowner/building owner must provide regular maintenance and debris removal as needed from any areas where SlimGuard is installed that may, because of roof design and/or conditions (including but not limited to roof valleys, gutter splash guards, etc.) collect debris.

**EXCLUSIONS AND LIMITATION OF REMEDIES**


